Several members of the 911 Coordinating Council attended the National Association of State 911 Administrators (NASNA) fall meeting in Kansas City on October 25th and 26th. Sherry Massey was invited to speak on behalf of the Council on her expertise involving GIS. Sherry has provided insight to the Council and our partners into what is needed to successfully implement geospatial call routing. Laurie Flaherty, Coordinator, National 911 Program at US Department of Transportation would like Sherry to participate in a nationwide webinar. Michele Abbott (Operations Chair) has had ongoing discussions with Laurie in regard to NG911 training standards and the Kansas 911 Coordinating Council. To further demonstrate the success of the NG911 Call Handling System implemented in Kansas, Scott Ekberg was contacted by several agencies that are interested in visiting Kansas to see the system we have implemented. While at the NASNA meeting, we met with Admiral (Ret.) David Simpson, Chief of FCC Public Safety and Homeland Security Bureau and Deputy David Furth of the FCC. Admiral Simpson and Representative Tom Sloan invited myself, Colonel Chris Stratmann (Vice-Chair) and Jay Coverdale (Technical Chair) to speak on Kansas NG911 on the cyber security panel that was held at the University of Kansas. What is your role with Kansas NG911?

Letter from the Editor- Lori Alexander, NG9-1-1 Liaison

On October 26, 2016 several PSAPs started receiving multiple 911 calls. These PSAPs did not know it at the time but they had just been the victim of a TDoS (Telephone Denial of Service) attack. 911 centers received 911 calls after a link on a Twitter account was clicked on. The device owners had no idea their device was calling 911. This tied up lines and dispatchers while they called back the device. What can you do to prevent your PSAP from experiencing an attack? Nothing....but you can be prepared and train to counter that attack.

This Month's Q&A



Q: If I have my own call handling equipment and network provided by a vendor can I connect to the 911 Council's network?

A: The 911 Coordinating Council's network is leased through AT&T. Until the nationwide ESInet is available the 911 Coordinating Council's network is a closed network.

Prepare for a TDoS Attack:

Make sure employees are aware of this type of activity.

Remind employees and the public not to click on unknown links.

Have a working relationship with your telephony provider to assist in the event of an attack.

Plan to log and record the calls for the investigation.

During an attack:

Have a secondary means of communication.

PSAPs on the Coordinating Council's Call Handling System should call the AT&T **Resolution Center first.**

Use social media and your local media sources to provide alternate numbers to obtain emergency services.

The attacks in October occurred in 11 states and affected many PSAPs. Fortunately none of them were taken down in the attacks. Two people were arrested in separate incidents and the URL has been taken down.

If your PSAP experiences an attack contact the 911 Coordinating Council for additional resources and assistance.
