# Message from the Chief Chief Dick Heitschmidt, NG9-1-1 Chair

Kansas now has 27 PSAPs operating on the 911 Coordinating Council's NG9-1-1 network with the addition of Norton, Morton, Grant and Yoder PSAPs in April.

During it periodic review, the 911 Coordinating Council focused on NG9-1-1 program status, cyber security, GIS data maintenance and the future of geospatial call routing.

A new subcommittee has been formed (Text to 9-1-1 & Public Education). The committee will be chaired by Rice County 911 Director Joshua Michaelis.

Thanks to the Shawnee County Sheriff's Office for hosting the Spring Kansas APCO Conference and to the numerous volunteers and vendors who assisted with another successful conference.

PSAPs needing hardware updates are scheduled and work has already begun. However, the Council decided to delay the upgrade of our call handling platform to R6.0 until R6.1 is tested and fully certified this summer. Working with their supplier, our provider AT&T uncovered some minor software irregularities that need additional attention. Rather than inconveniencing our PSAPs twice, we decided to wait and catch the following software release. Future newsletters will keep you posted on progress.

**Questions for the PSAP:** 

How does data flow through your organization?

What does your workflow look like?

steward is responsible for assuring the maintenance is performed on the GIS data and that updates are report to the Coordinating Council. The data steward must be a staff person for the City or County responsible for the PSAP; even if a vendor handles the actual data maintenance. Every PSAP has to have a data steward. Possible candidates are the PSAP director, PSAP supervisor, or Sheriff/Undersheriff.

Data Steward: The data

## Data Maintainer:

responsible for performing the actual GIS data maintenance. This person may be a vendor. Every agency must have a data maintainer. The data maintainer will be involved in the work flow involving address changes, corrections, additions, new roads, closed roads, changed roads, new addresses, annexations and emergency service boundary changes. Data changes should be maintained in the portal on a regular basis. If you have changes weekly then you should update the data weekly. If your agency has no changes you must report "no changes" quarterly. Mandated report dates are: January 1, April 1, July 1 and October 1.


# This Month's Q&A



Q: I can purchase my own equipment. Why should I consider the 911 Council's Solution?

A: The solution is not just the equipment. It is the network and infrastructure behind the solution including: 24/7 monitoring and technical support,

**NENA compliant IP network** that will deliver i3 services (text-to-911, geospatial call routing, picture and video messaging, etc.), redundant connectivity, initial and ongoing training, and reroute and overflow options for 911 calls. In addition the **Council offers routinely** updated statewide mapping and aerial imagery to further enhance the delivery of emergency services.

### Cyber Risks to NG 9-1-1

In March members of the 911 Council attended APCO's Emerging Technology Forum where there was a lot of discussion on cyber security. The Council is committed to protecting the network to ensure the PSAPs are supported. The Council is up to date on NENA and APCO standards as are our vendors. What can the PSAP do to prevent the loss of services? In a word.....training. It is recommended that PSAPs provide cyber security training 4 times each year. Insider threats both intentional and unintentional are real concerns. A PSAP recently lost their 911 call taking ability when a PSAP employee plugged a personal device into the USB of the phone system. Are you PSAP employees trained not to access USB drives?
