Message from the Chief Chief Dick Heitschmidt, NG9-1-1 Chair

Some exciting things are happening in the NG9-1-1 world. A year ago, the Federal Communications Commission (FCC) formed the Task Force on Optimal PSAP Architecture ("Task Force"). The Task Force studied the progress of transition to NG9-1-1 nationwide. The conclusion of the report is that many states are not adequately addressing the Congressional vision for NG9-1-1. As a result, on July 7, 2016, Rear Admiral (retired) David Simpson, Chief Public Safety and Homeland Security Bureau, sent a letter to all state governors. The letter expresses disappointment and concern that a large number of jurisdictions have stalled in their transition from legacy 9-1-1 service to NG9-1-1. It is with great pride that I can reassure our governor that Kansas NG9-1-1 is not stalled. In fact, Kansas is a national leader in transition to NG9-1-1. For example, by next week, we will have migrated 34 PSAPs (34% of the state) to the statewide solution. Our success is attributed to a phenomenal team effort by all of our stakeholders. And so, on behalf of the 9-1-1 Coordinating Council, please accept a big "Thank you and well done, Kansas."



Vesta Release 6.0 and 6.1

Release 6.0 was successfully deployed over a two week period in June.

Release 6.1 is still in the testing labs at AT&T. We will have more information as it becomes available.
