As many of you are aware, several of our PSAPs have legacy 9-1-1 equipment that has failed over the last several months. Still others have legacy equipment that failed long ago. And several others may be on the verge of failing in the near future. These failures are the result of discontinued support from the original manufacture.

The Council anticipated the failure of legacy equipment a number of years ago. With this in mind, we expedited the design and delivery of our new NG9-1-1 platform. In addition, our contract for NG9-1-1 services is structured to prevent a recurrence of discontinued support from manufacturers. That's one of many benefits of getting on NG9-1-1 as soon as you can.

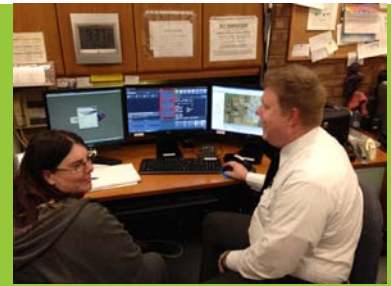

Frequently Asked Questions

Do I need any special insurance?

No, the property insurance that you currently carry for the protection of your equipment is sufficient. If you do not have insurance, the Council recommends that you do.

Why can't we just stay on our current system?

You can. The problem is that legacy equipment is failing, may not be supported, and the network is in the sunset phase.

How old is the current legacy system?

The technology that current legacy systems are based on is over 40 years old.

How does Kansas compare with the rest of the United States?

Kansas is in the top nine states actively

Is NG911 better than what I currently have?

NG911 will offer geo-spatial routing, text, photo, video, Telematics as NENA releases new standards.

What if I decide to "go-it-alone"?

Your system may not be compatible with or interoperable with the statewide NG911 system. And the costs will become overwhelming as you are forced to all-IP technology.

Will we need special training?

Yes. While much of NG911 call handling is similar to what you are doing now, there are new procedures. Don't worry, we will give you everything you need.

Are there advantages to PSAPs collaborating and forming partnerships?

Yes. Neighboring PSAPs can back up each other during emergency situations, and in some cases may be able to reduce total seat count.
